*\*High School Driver Education Certificates, Form I-DE-4, and Adult Driver Education Certificates, Form I-DE-5, shall, in the judgment of the teacher, be awarded only to students demonstrating mastery of recommended course content and a satisfactory level of driving performance (i.e., student ability to consistently control the speed and direction of the vehicle and to safely operate the motor vehicle on the public streets and highways*

*\*Students currently enrolled in Driver Education without a permit should be given an adequate amount of time, possibly into the next school year, to obtain a permit and complete their in-car practice once the DMV re-opens.*
